ANY HOPE FOR REJECTED DIASPORA VOTING BILL

s it says, "a setback often moves us to a road that is even worse but leads to an even better destination". -Winston Churchill.

Participating in elections is a civic responsibility of the citizens of the nation. This affects the quality of life and makes difference in the community.

Most Nigerians home and abroad are deeply interested in voting for their preferred candidates at all levels of government.

This interest brought about the need to sponsor the Nigeria Diaspora Voting Bill.

The Bill aims to pave way for Nigerians in the Diaspora to cast their votes from their countries of residence without having to go through the stress of travelling down to Nigeria to exercise their franchise.

Efforts have been intensified by involving all hands on deck to advocate for its existence.

Sadly, the bill which made it to the final reading was voted against by both Nigeria's upper and lower legislative houses on March 1st, 2022 during the constitutional Amendment Review Session (third reading) held at National Assembly Complex in Abuja.

The upper chamber (Senate) voted: Yes = 29 and No= 62.

The lower chamber (House of Reps) voted: Yes = 58 and No = 240.

The bill seeks to amend section 77 Subsection (2) of

the Principal Act to now read " Every citizen of Nigeria, who has attained the age of eighteen years residing within or outside Nigeria at the time of registration of voters for purposes of election to a Legislative house, shall be entitled to be registered as a voter for that election."

Femi Odere, the Chairman, Association of States' Diaspora Focal Point Officers, in a statement, described the turnout as not only set back the hands of the nation's democracy clock, but also disenfranchised a huge segment of Nigerians in the Diaspora who are, without doubt, necessary for, if not indispensable to, the socio-economic development of the nation.

According to the statement, the importance of Nigerians in the Diaspora to national development has been demonstrated by the Buhari administration with the establishment of Nigerians in Diaspora Commission (NiDCOM). With this, virtually all the states in the federation now have Diaspora Focal Point Officers (some states have full Ministries or Commissions) to drive economic developments at the sub-national levels, which has been yielding the desired economic results for these states. It therefore beggars belief that just when all hands are now on deck for the inclusion of Nigerians in Diaspora into the nation's development matrix through specific tools such as the proposed "Nigerians in Diaspora Investment Trust Fund" by NiDCOM and several other policy





instruments and programmes by the states, what the National Assembly had done and said in no uncertain terms, with the rejection of the Diaspora Voting Bill, is that this incredible critical mass of our people, whose collective a n n u a l remittances dwarfs the country's annual budgets in most cases, do not matter in the overall socioeconomic and political scheme of things.

The group also believes that the rejection of the Diaspora Voting Bill has not only sent a very wrong signal but a wrong step in the wrong direction. They therefore wish that the Bill will be rerepresented for the right thing to be done.

The National Diaspora Voting Council (NDVC) in a statement issued by its Secretary, Tolu Oluwatuyi described the setback as a renewed determination and pledged to double-up on its efforts to widen and intensify its scope of diplomacy and restrategise going forward.

The Council, however, thanked its Chairman, Prince Ade Omole, the board members, Executives, and members for their patriotism, dedication and commitment to the DV advocacy.

They equally showered accolades on Sponsor of the Nigeria Diaspora Voting Bill, Hon. (Mrs) Tolulope Akande-Sadipe, House Committee Chairperson on Diaspora Matters, who worked relentlessly with her ever untiring team led by Mrs Omoshalewa to ensure that the Bill saw the light of the day.

The Council also thanked her for the many travels she embarked on during the zonal public hearings in a bid to ensure that the Diaspora Voting Bill was a success.

The Council specifically thanked the various major stakeholders who have equally been in the constant advocacy for the materialisation of the DV Bill. They appreciated the Nigerians in Diaspora Commission (NiDCOM) under the able leadership of Hon. (Mrs) Abike Dabiri-Erewa; the Independent National Electoral Commission (INEC) under the chairmanship of Prof Mahmood Yakubu, for the technical know-how support and willingness to help thus far; the Nigerians in Diaspora Organisation (NIDO) and other Diaspora groups and persons for their unflinching support and commitment.

NDVC also assured that they will not relent in their efforts to spread their advocacy until the goal isu achieved.

It is expected that the bill will be represented during the 10th National Assembly for reconsideration.

o one prays for war, however the realist approach in International Relations explains the emphasis to the role of the state, national interest, and power in world politics. This means humans are driven by lost of power and desire to dominate others.

For those who haven't experienced war, it's really not a good sight and should not be welcomed. The world was thrown into chaos especially, young Nigerian students studying in Ukraine after Russia invaded Ukraine; burning down some parts of the country.

As a mother, the Chairman/CEO, Nigerians in Diaspora Commission, (NiDCOM), Hon Abike Dabiri-Erewa saw the need to engage the Nigerian-Ukrainian evacuees in post-traumatic therapy because most of these young students were still traumatised by the horrific experience in Ukraine having first-hand knowledge of the war.

In addition, the organisation is bringing value on board to NiDCOM in resources, stating that the Nigerian resources in the Diaspora can be pulled back especially on independent investigation, putting an end to accidents in Nigeria.

Shehu added that it became necessary to partner with NiDCOM in order to broadcast and showcase the passion of ASSP which Nigerians in the Diaspora can freely network and engage with the organisation.

society is made up of communities. According to the Oxford Dictionary, a society means "people in general living together in communities".

Also, it could be termed, "people grouped together based on shared geographical territory, and common culture".

These communities are made up of cultural norms, traditions that are linked to a people. Therefore it is safe to say that the society is an interdependence of different communities woven together.

We, as individuals, belong to groups we can identify with and have similar goals or ideologies, inside communities. This is referred to as a group.

In an elaborate way, a social group is made of certain number of individuals who share common identity, goals, common solidarity, and shared norms.

The diaspora is made of several communities; with the sociocultural groups being among the largest (if not) the largest group of all.

Take Nigeria for instance, there are many nationals living in Nigeria. Like the Asians, Americans and other Africans. Still an example, the Asians could have "Asians United Nigerian Chapter". So whether you're Philippine, Chinese, Malay, Indian, Thai or Vietnamese, you belong to it; if you so desire.

Going further, other sub-groups will emerge like "Associations of Indians living in Nigeria", and another group could emerge to unite all Rajasthani or Punjabis living in Nigeria, for example.

ethnicity, origin, but by your country or race? Imagine, you come across a very familiar, common Nigerian name, in a place far from home. You get this feeling of reconnecting with a lost brother. It doesn't matter what part of Nigeria he or she is from but the fact that you met another Nigerian in a foreign land. Also, this creates some bonding among people.

These groups asides preserving culture and reconnecting with one another, contribute in developing host country and their countries of origin. PVC, NiDCOM, NCFRMI Offers Free Trauma Clinic To Nigerian Students From Ukraine

kraine's ministry of education and science, Morocco, Nigeria, and Egypt are states in the top 10 list for countries whose students are studying in Ukraine, accounting for 8,000, 4,000 and 3,500 students respectively. The three countries made up nearly 20% of all foreign students in Ukraine as of 2020. Russia's Invasion on February 24 has damaged and destroyed schools and universities.

A large majority of Nigerian students living in Ukraine had to flee their place of residence after Russia invaded the country in February. They left behind everything. Thousands of Ukrainians have been killed and injured, including children. Daily pictures and video of atrocities suffered in Ukraine are splashed across the media.

In an attempt to improve the traumatic plight of Nigerian returnees from Ukraine, a two-day psychosocial Trauma Clinic For Ukraine returnees was created and coordinated by Nigerians In Diaspora Commission (NiDCOM) in conjunction with the National Commission for Refugees, Migrants And Internally Displaced Persons (NCFRMI). The opening ceremony which took place at the State House Auditorium, Presidential Villa, the President of PVC NAIJA and the initiator of the project, Dr Bolaji O. Akinyemi said the initiative became necessary because "when we have events that expose individuals to trauma, it is better that we nip them in the bud and that was what informed the idea of this project".

He urged the returnees to open up during sessions with the experts as the programme is meant to help them, saying that "I believe that you will get the needed help, we're trusting that we will take this to all the regions so that people won't have to travel to access this."

The Chairman/CEO Nigerians in Diaspora Commission, Hon. Dabiri-Erewa appreciated Dr. Akinyemi for the initiative said that "the passion with which he said we must do this for them, I agreed with him completely."

The NiDCOM boss said that she quickly reached out to the Commissioner, National Commission for Refugees, Hajiya Imaan Suleiman-Ibrahim who said that "we must do this as quickly as possible."

She announced that the profiling and detention of Nigerians and other African nationals in Poland detention centers is highly unacceptable and reprehensible. She added that two day clinic was the preliminary, as it will be a continuous exercise in the six geo political zones. The Commission quickened partnership with The Sunshine Series to create a 24 hours helpline (#112) for returnees who need counseling.

Dabiri-Erewa noted that though President Mohammadu Buhari had made every necessary arrangements for Nigerians caught up in the war situation to return home, some chose to remain in some countries like Poland, stressing that the most appropriate action for Poland to take was to return them back to their countries, rather than keep them in tortuous detention centers.

According to Hajiya Imaan Sulaiman-Ibrahim, Federal Comissioner, Refugees Cmmission, "We tend to ignore our mental health but mental health is key.

"As Nigerians we have a lot of resilience we have that ability, but not everybody has the same threshold when it comes to resilience and hence the need for this particular platform so that those that need extra support or extra care and assistance, can be able to access it".

Hajiya Sulaiman-Ibrahim stated that the NCFRMI is the focal organ of government for rehabilitation, resettlement and integration and psychosocial support is the core of rehabilitation.

She went further to explain that NCFRMI has offices in about 14 locations and are ready to make their offices available to ensure that collaboration with the Project Victory Call Initiative (PVC) team and academic experts make this counseling easily accessible for the returnees.

The president of Nigeria Students in Ukraine, Mr Fehintola Damilola Moses, narrated the gruesome living conditions they had to endure before help arrived from the Nigerian Government. In his words" We had to boil snow to drink water ". He expressed how brutal the situation was and the terrifying experiences most of them faced during the war between Russia and Ukraine. From spending nights in an inadequate bunker to being racially profiled in some instances.

He applauded President Mohammadu Buhari, the Minister of foreign Affairs, H.E Geoffrey Onyeama, Hon. (Dr.) Abike Dabiri-Erewa and the Nigerian in Diaspora Commission (NiDCOM) team , the Nigerian Ambassador to Ukraine, Amb. Shina Feege , Nigerian diaspora organizations, NGOs and all other government agencies for the prompt response and rescue of the students from Ukraine.

FOOD CORNER

Awara is a very good source of protein, and meat substitute option for vegetarians. Awara is either called fried soyabean curds or tofu. It can be eaten any time of the day and it's a popular delicacy among the northern and western parts of Nigeria.

INGREDIENTS

- 1. Cups soya beans
- 2. Groundnut oil (or any other vegetable oil, for frying)
- 3. Chilli pepper
- 4. Medium-sized onion
- 5. Seasoning cubes
- 6. Crayfish (optional)
- 7. Alum
- 8. Salt

METHOD

1.Soak the soya beans till it's soft; then wash grind the beans. After grinding the soya beans sieve to extract the milk and throw way the chaff.

2. Pour the sieved content gotten from the soya beans in a sizeable pot and put on fire.

3. Soak the alum in two litres of water. Immediately the soya milk starts to simmer, add the alum solution gradually till the soya milk curdles or form lumps. Once it curdles, stop pouring the alum solution and let it boil for 20 minutes. 4. After 20 minutes, pack out the lumps into another separate clean pot- add maggi, salt, pepper, onion, crayfish, and mix all together.

(Soya Beans Tofu) RECIPE

5. Put it back on fire to cook for about 20 minutes then you bring down and allow it to cool down.

6. Get a clean sieve cloth (like a muslin fabric for processing pap) and pour it in and tie up. Place it on a clean surface. Get a clean heavy object to squeeze the water out completely. Allow it for some time depending on when you will want to use it.

7. When it is ready to use, cut it into your desired shapes and sizes.

8. Heat up your fry pan; add vegetable oil, when it's hot, slice the onion and put into the pan- allow to fry a little, then you add the soya bean curds into the pan.

9. Place on a medium heat till it turns light or dark brown, depending on what you want Your soya beans tofu is ready to be served.

NB: blend pepper and onion to a coarse texture to prepare some sauce and eat with it.
